Question 1

- (a) (i) Identify the message(s) contained in **Source 1**. (2 marks)

- (ii) Compare and contrast the messages of **Source 1** and **Source 2**. (4 marks)

- (b) How useful are **Sources 3** and **4** for learning about an important political change during the period of study? (4 marks)

- (c) (i) Identify **one** trend evident in the election results in **Source 5**. (2 marks)

- (ii) How can you account for the trend identified in **Source 5**? (3 marks)

- (d) Identify the perspective of **Source 6** and comment on the beliefs, values and/or attitudes in the extract. (4 marks)

- (e) To what extent do the **six** sources reflect the political changes that took place during your period of study? In your answer, comment on which political changes are included and discuss any omissions. (6 marks)

Question 2 (25 marks)

Using a key international conflict/war from your period of study in which Australia was involved.

- (a) Describe the reasons for Australia's involvement in the conflict/war. (10 marks)
- (b) Analyse the consequences of involvement in the international conflict/war on Australian society during your period of study.
Your answer could include discussion of the social, political and economic consequences. (15 marks)

Question 3 (25 marks)

With reference to at least one social group or movement you have studied (for example, Aboriginal people, women or migrants), describe and evaluate the progress made by the group/movement during your period of study.

Your answer could include:

- a description of the social group/movement at the start of the period of study
- key events and changes experienced by the group during the period of study
- a discussion of the social group/movement at the end of the period of study
- a judgment/evaluation as to how much progress had been made over the period.

Question 4 (25 marks)

Outline and assess the extent of changes to Australian national identity that took place during your period of study.

Your answer could include:

- an outline of Australian identity at the start of the period
- key events/changes that shaped Australian national identity during the period
- an outline of Australian identity at the end of the period of study
- an assessment of the importance of the changes to identity you have described.

- (e) How important are the themes/issues represented in the sources within the context of the area of study? (6 marks)

Question 6 (25 marks)

- (a) Describe the causes of a significant political event linked to the rise of the historical movement you have studied. (10 marks)
- (b) Analyse the consequences of this event for the historical movement and for groups opposed to it.

Your answer could include:

- a discussion of any new laws introduced
- leadership changes
- domestic/international reaction to the event. (15 marks)

Question 7 (25 marks)

Discuss the importance of ideas/ideology in contributing to the development of the historical movement you have studied.

Your answer could include:

- a description of key ideas/ideology associated with the historical movement
- the importance of these ideas on the growth of the movement
- alternative factors that may have helped the development of the movement.

Question 8 (25 marks)

‘The progress made by any historical movement can be explained by the effectiveness of its leadership.’

With reference to the historical movement you have studied, to what extent do you agree with this statement?

Your answer could include:

- the role of leadership in the development of the historical movement
- the extent to which the leadership was effective
- any other factors that may have helped the rise of the historical movement.
